

The Grand Jury of said County charges that before the finding of this indictment that,

STEVE DEBOSE, whose name is to the Grand Jury otherwise unknown, did intentionally cause the death of another person, to-wit: Hoover James Simmons by strangling him and/or beating him with a blunt object, a better description of which is to the Grand Jury otherwise unknown, and the said STEVE DEBOSE, caused the death during the time that he was in the course of committing a theft of property, to-wit: Lawful United States currency and/or Lawful United States coinage, and/or one (1) Grey 1991 Cadillac Deville, and/or one (1) .32 caliber H and R Revolver, and/or one (1) datebook/organizer, and/or one (1) Alabama Driver's License, and/or one (1) Social Security card, and/or one (1) Medicare card, and/or one (1) Exxon Mobil Credit Card, #7302444707568242, and/or miscellaneous keys, a better description of which is to the Grand Jury otherwise unknown, the property of, to-wit: Hoover James Simmons, by the use of force or by threatening the imminent use of force against the person of the said Hoover James Simmons, with the intent to overcome his physical resistance or physical power of resistance or to compel the acquiescence to the taking of or escaping with the property, while the said STEVE DEBOSE, was armed with a deadly weapon or dangerous instrument, to-wit: a blunt object, a better description of which is to the Grand Jury otherwise unknown, in violation of Section 13A-5-40 of the Code of Alabama,
