State budgeting, euthanasia Rep. McMillan's top-billed items

MONTGOMERY —
State budgeting and
euthanasia of dogs and
cats are among the topics Rep. Steve
McMillan, R-Bay
Minette, is ready to
take on in the current
session of the Alabama
Legislature.

With legislators believing this is the worst economic time in the state's history, McMillan said some things are going to have to change.

"The economy in this state is probably the worst it's been since I arrived in 1980," he said.

The state has two main budgets: The Education Trust Fund and the General Fund.

"Alabama had the largest ETF budget in the state's history just two years ago," We have lost \$1.5 billion in revenue. The Legislature made a big mistake when times were good by using one-time revenue and too much new revenue to meet recurring expenses. When revenue fell, we had no way to replace those sources of revenue.

McMillan said.

With the ETF in its third straight year of proration, or budget cuts Gov. Robert Bentley has ordered 3 percent proration in this year's spending.

"I predict legislative decisions will focus on saving jobs, which will not be an easy task," McMillan said.

The General Fund has also taken a big hit over the last few years-something McMillan would like to see changed. He admits it might take time.

"There is no silver bullet, quick fix approach to this problem," he said.

The General Fund makes little revenue from growth taxes such as the income tax and sales tax.

Insurance premiums are the No. 1 source of revenue for the General Fund.

McMillan believes a

major change in state budgeting may be coming during the next few weeks.

"I predict we will adopt a new process, which will eliminate adopting budgets based on revenue estimates." He said. "Instead, the maximum revenue estimate will be based on the previous year with growth estimates capped at the average growth for the last 15 years."

McMillan admitted that this step may not completely fix the problem, but said, "It will be much more responsible and should eliminate proration as a frequent occurrence."

Budget cuts are not the only thing on McMillan's agenda.

He is sponsoring a bill that would eliminate the use of gas chambers to euthanized dogs and cats in animal shelters.

"Bill 147 has gained, a lot of support and will have a Senate companion," he said. "The only reason it has not been introduced is because there has been a lot of people wanting to cosign the bill."

The Senator sponsoring the bill will wait till later in the week to introduce the bill.

McMillan said he also wants to introduce legislation that would dincrease punishment for the people who harm, abuse or kill children.
